Notice under section 708(A)(5)(e) of the Corporations Act ('Act') and Appendix 2A

On 9 February 2021, Lithium Australia NL (ASX: LIT) ('the Company') issued a total of 2,628,565 fully paid ordinary shares in the capital of the Company ('Shares') following the satisfaction of price milestones of performance rights (2,625,000 Shares) and the exercise of LITO options (3,565 Shares raising \$428).
