## LITCF shares transferred and 3,127 shares issued

Lithium Australia NL (ASX: LIT) ('the Company') advises ASX that auction formalities have now been completed and 50,000,000 partly paid shares paid to \$0.0101 and unpaid \$0.0499 in the capital of the Company ('LITCF') have transitioned from LITCE partly paid shares.

The Company is pleased to advise that 50,000,000 LITCF partly paid shares have transferred, and the total now designated LITCF amounts to 86,238,765 LITCF which is 50.16% of the LITCE partly paid shares called, which is reasonable in the current CoVID-19 circumstances. Statements will be issued shortly to these LITCF partly paid shareholders who can trade under the symbol LITCF.

The Company now confirms that the 85,675,026 LITCE shares (Forfeited Securities) in the Company have now been duly forfeited on 15 May 2020 and this statement is prima facie evidence of the facts stated as against all persons claiming to be entitled to any of the 85,675,026 LITCE shares. A total of **85,675,026 Forfeited Securities** have been forfeited as of today's date and transferred to the Company's Treasury Account. As advised in the ASX release dated 13 May 2020, shareholders have until 30 May 2020 to make an offer for the Forfeited Securities. Following the close of the offer period, any Forfeited Securities not transferred by this process, can be disposed of in such manner and on such terms as the Directors determine.

### Issue of 3,127 shares

The Company advises that it has issued 3,127 fully paid ordinary shares in the capital of the Company ('Shares') following redemption of LITCE shares prior to the auction.
